- Applicants are responsible for all transportation from parking areas and from the festival site. Any unauthorized vehicles left on the festival site after the conclusion of the festival are subject to towing at owner's expense. Vendors must be packed up and off-site by 9:30 p.m.
- At the festival site, serving or selling any food or beverages including water is prohibited, unless a food vendor application has been submitted and approved.
- Vendors must supply table cover and table skirt.

**IN ORDER TO PROCESS THIS APPLICATION, THE AGREEMENT ON THE REVERSE SIDE MUST BE SIGNED AND DATED. ANY APPLICATIONS RECEIVED WITHOUT THE AGREEMENT SIGNED WILL BE RETURNED WITHOUT PROCESSING. NO APPLICATION IS COMPLETE WITHOUT PAYMENT.**

**2019 Gainesville Pride Festival Agreement**  
2019 Gainesville Pride Festival, October 26, 2019

In signing this agreement for the 2019 Gainesville Pride Festival vendors agree to each and all clauses set forth in this agreement. Failure by the vendors to abide by any clauses set forth in this agreement gives Pride Community Center of North Central Florida, Inc (hereinafter known as PCCNCF) and/or the authorized agents of PCCNCF the right to (1) immediately terminate this agreement (2) require vendor, immediately upon notice of violation of this agreement, to cease operations and vacate the premises, and (3) forfeit any and all fees paid to PCCNCF for the right and privilege of participating in the festival. No clauses of this agreement may be changed in any way or altered without the written, signed permission of PCCNCF.

1. PCCNCF agrees to provide each vendor with assigned space(s) at the 2019 Gainesville Pride Festival.
2. PCCNCF retains the exclusive rights to serve and sell water at all sites and operations of the 2019 Gainesville Pride Festival. Anyone wishing to sell or serve either food and/or beverages at any and all sites of the 2019 Gainesville Pride Festival must complete and submit a Food Vendor Application to PCCNCF.
3. Pride Festival vendors shall not display, offer for viewing, or sell any illegal or contraband items. The laws of the State of Florida and local ordinances of the City of Gainesville and Alachua County shall control. Pride Festival vendors shall not display, offer for view or sell any items that are unlicensed and/or copies/interpretations of licensed or registered items at any and all sites and operations of the 2019 Gainesville Pride Festival. Pride Festival vendors shall comply with all federal, state and local laws.
4. Pride Festival vendors shall not display, offer for viewing, take orders for, or sell any items that are imprinted, emblazoned or marked in any manner with any and all the words "**2019 Gainesville Pride Festival**" even when printed with other words. Pride Festival vendors shall not offer phrases, logos or artwork with any variations of these words.
5. Pride Festival vendors shall not sublet their space to anyone.
6. Pride Festival vendors acknowledge and understand that they are responsible for sales and use tax and shall in no way hold PCCNCF or its representatives responsible for any type of permits other than for the festival itself.
7. Refund Policy: A full refund will be given to a written request received by October 12th, 2019. No refunds will be given for any request received after October 12th, 2019.
8. PCCNCF makes neither representation nor guarantees towards actual festival attendance.
9. Pride Festival participants understand that PCCNCF has no control over weather, acts of God, acts of terrorism, or governmental intervention, or any other cause that may prevent, and or interrupt, the festival weekend, and vendors shall hold PCCNCF harmless for any losses that could arise because of such event.
10. PCCNCF reserves the right to place Pride Festival vendors in a location at the complete discretion of PCCNCF. Pride Festival vendors may request a preference of placement, however, PCCNCF shall have sole and complete authority to place the vendor in any location contained in the festival site, irrespective of the vendors' request.

Any modification of this agreement shall be null and void unless said modification is set forth in writing and signed by the same parties (or his/her representatives) having signed this agreement. **The Pride Festival Vendor hereby absolves PCCNCF of any liability arising from participation in the Gainesville Pride Festival or any activities in association with the Pride festival and parade.**

This agreement has been read, understood and entered into freely, voluntarily and absent of duress by the parties signed below.
